Dismissal:

2. The Civil Service Board (the "Board") does not have jurisdiction to hear this matter because the examination at issue is the subject of a federal Consent Decree (a court order) and the relief requested would violate that Decree.

3. The Board does not have jurisdiction to hear alleged violations of collective bargaining agreements.

4. The grievance does not state a violation of a grievable Civil Service Rule and requests relief that is outside the authority of the Board.
