VII. Committee Reports

A. Community Relations Committee

1. Meeting with Dr. Annmarie Kent-Willette, Education Commissioner - City of Jacksonville



The committee asked Dr. Annmarie Kent-Willette to attend its meeting to discuss youth and education. The FCAT results are the focus for teachers. Multi-cultural awareness and social issues are also needed. It was stated by Dr. Kent-Willette that teachers last approximately 3 years and 72% of babies are born into single parent households. Many new teachers are not equipped to handle the social and cultural issues of youth.

Dr. Kent-Willette also stated that Jacksonville schools are being compared to St. Johns County schools, which are very different because Jacksonville is an "urban" city.

Commissioner Nathan Rousseau suggested that a public forum be held on issues concerning youth, i.e. nine and ten year olds going to jail, lack of social and cultural learning, and inequality across schools, etc. Jacksonville University Public Policy Institute could conduct this forum.

 50th Anniversary of the Civil Rights Act of 1964 Meeting with Lisa Buggs, Community Education and Enrichment Program Supervisor, Jacksonville Public Library

Commissioner Casey Bulgin, Committee Chair, stated the committee discussed ideas for the 50th Anniversary of the Civil Rights Act of 1964, which is July 2, 2014. Lisa Buggs attended the meeting and stated the library could provide a feature section of reading materials on the Civil Rights Act and Japanese American Internment, recommend books for its Book Clubs, feature a story in its newsletter and display appropriate materials and posters.

The committee agreed to have an open dialogue session (similar to Study Circles) which would lead up to a keynote speaker. The committee would also like the cultural community to come together with a music and dance feature of how the Civil Rights era influenced music. The Community Relations Committee and any other Commissioners who are interested will meet on Tuesday, March 25, 2014 at 11:30 a.m. at City Hall in Conference Room 3D to discuss the anniversary program.
