Meeting Convened: 1:30 PM

Dr. Moreland opened the meeting and introduced the Committee Members.

He advised that Sam Mousa, prior Committee Chair, has retired and Marlene Russell, prior Committee Staff, will be retiring at the end of this month.

He introduced the new Staff member, Tina Thompson.

Election of Vice Committee Chair:

Motion made by Dr. Moreland to elect James Croft. The Committee 2nd the motion.

Meeting Minutes November 22, 2019:

Motion made by James Croft and seconded by Dr. Kristen Reed to approve the minutes with no edits; Committee approved the minutes.

Review of Ordinance/Executive Order:

Dr. Moreland reviewed with the Committee. He discussed the Sunshine Law, and the importance of not sharing documents within the Committee. Conflict of Interest was discussed at this time.

Dr. George Candler, Director, MPA Program:

Dr. Candler discussed the MPA program at UNF, and advised that there are currently 69 actively enrolled in the program.

He advised that when the announcement is released, he will notify the students that are enrolled in the MPA program.

Dr. Candler voiced his opinion that the UNF Committee member should be held by the UNF MPA Director. No vote was taken by the Committee at this time.

He also proposed a change to the Rules of Procedure, Section III-Annual Timeline, recommending moving the July date back to June.

This recommendation was not voted on by the Committee at this time.

James Croft:

The City of Jacksonville website will be updated to reflect the change of Committee Chair, newly elected Vice Chair, and new members.

Advertising process:

Dr. Moreland reviewed the advertising process and the timing required of same.

Advertising for the Spring 2022 Term will begin immediately.

The Committee agreed to advertise for 6 weeks. Advertising will commence in August 2021 in the Jax Daily Record or Jacksonville Business Journal, The Spinnaker(UNF) and the City of Jacksonville website.

The Committee was advised that this process will also begin in March 2022 for the Fall 2022 Term.

Application Open/Closing for Spring 2022 Round:

The posted timeline for Spring 2022 was reviewed and agreed to proceed as noted.

Application closes September 15, 2021

Review and score applications October 2021

Notify winners November 2021

Award scholarship December 2021
