Chairman Snell led those attending the meeting in the Pledge of Allegiance, after which he gave the invocation.

- 1). Chairman Snell asked to the public if would like to address the Board. No one did.
- 2). Chairman Snell asked for approval of the July's minutes. Mr. B. Soles moved to approved minutes. Mr. B. Cornellier seconded, and every member of the board agreed; the motion passed.
- 3). Chairman Snell asked about the New Administrative Complaints, Mr. C. Benson informed the Board that will be one new case so far for next agenda September 10th.

4). Chairman Snell asked about the Administrative Complaint filed against Edward M. Tipton d/b/a/Tipton Remodeling, LLC., to property located at 7678 Crosstree Lane, by Charles Benson. Mr. Edward M. Tipton was not present. Homeowners were not present. Mr. C. Benson clarified to the Board that this case was heard back on December 11th, 2024, and Mr. Tipton never responded to complete stipulation agreement with the city or homeowners.

MOTION: Mr. B. Soles made a motion to accept all recommendations. Mr. B. Cornellier seconded, and the motion passed.

5). Chairman Snell asked about the Administrative Complaint filed against Donald Anthony Cicale d/b/a/ Don's Air Conditioning Inc., to property located at 5613 Hickson Road, by Charles Benson. Mr. Donald Anthony Cicale was present. Homeowners Michael and Jill Moore were present. Mr. C. Benson presented the case to the Board, referring to violation of a HVAC contractor pulled permits for an unregistered person/contractor. Chairman Snell asked Mr. Cicale, if he understand the charges and how he plead, and he said not guilty. Homeowner Mr. Moore explain to the Board that the contractor sent them a check for \$2,431.35.

Benson presented the case to the Board referring to violation causing financial harm to a customer of \$108,728.60.
