AMENDED NOTICE TO PUBLIC PROPOSED USE OF HUD ESG RUSH FUNDS

On January 10, 2025, the Department of Housing and Urban Development's (HUD) Office of Special Needs Assistance Programs announced that Jacksonville-Duval County would receive a special allocation of the Emergency Solutions Grant (ESG) to address the needs of individuals and families experiencing homelessness or are at-risk of homelessness in areas affected by a major disaster declared area pursuant to the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5121 et seq.) This special allocation of "Rapid Unsheltered Survivor Housing" (RUSH) funding under the ESG Program aims to address homelessness in areas affected by disasters by filling gaps in federal assistance.

The City has been awarded an allocation of \$1,000,000 in RUSH funding. Funds will be used for approved services to address the needs of individuals or families who are homeless or at risk of homelessness within the President's major disaster declarations dated September 28, 2024, DR-4828-FL, for Hurricane Helene, and October 11, 2024, DR-4834-FL, for Hurricane Milton.

The plan is to distribute ESG RUSH funds as follows:

Rapid Re-housing	\$405,000.00	40.5%
Street Outreach	\$5,000.00	0.5%
Emergency Shelter	\$490,000.00	49.0%
Homeless Management Information System (HMIS)	\$25,000.00	2.5%
Program Administration	\$75,000.00	7.5%

As of the publishing date of this notice these proposed activities to be funded with ESG RUSH have yet to occur.

To receive ESG RUSH funds, the City of Jacksonville must submit for HUD's approval, a substantial amendment to the 2024 Annual Action Plan.
