NOTICE TO PUBLIC OF PUBLIC HEARING for the 2025 ANNUAL ACTION PLAN

April 10, 2025

Notice is given that the City of Jacksonville's ("City") Housing and Community Development Division ("HCDD") will have a public hearing to provide an overview of the draft 2025 Annual Action Plan ("AAP"). The AAP provides a summary of the actions, activities, and specific resources that will be used each year to address needs and goals identified by the 2021 – 2025 Consolidated Plan. The Public Hearing is scheduled for April 23, 2025 at 11:00AM in Conference Room 851 at 214 N. Hogan Street, Jacksonville, Florida.

The City expects to receive an estimated \$6,853,388 from the annual CDBG allocation and \$187,711 in program income and \$499,408 in reprogrammed funds for a total of \$7,540,507. For the HOME program, the City estimates receiving \$3,247,217 from the annual allocation, \$440,915 in program income and \$1,815,396 in reprogrammed funds for a total of \$5,503,528. For the ESG program the City estimates receiving \$582,374. For the HOPWA program the City estimates receiving \$3,112,672 and \$215,577 in reprogrammed funds for a total of \$3,328,249.

At this time HUD has not yet announced the FY 2025 Community Planning and Development (CPD) allocations. The allocations below are only an estimate of the anticipated city's PY 2025 allocations and the City has a contingency provision to match the actual allocation amount once it has been announced by HUD. The City's final allocation towards activities in the AAP will be divided among all proposed projects and budgets will be proportionally increased or decreased from the estimated funding levels to match the actual allocation amounts, with adjustments to remain in compliance with activity funding caps as required by HUD. Please see the estimated 2025 AAP budget that includes the allocations from HUD and the estimated program income that will be collected below:

CDBG: Administration (20% max cap): \$1,370,677

CDBG: Public Facilities & Infrastructure (69%): \$5,175,899

CDBG: Public Services (15% max cap): \$993,931.00

HOME: Administration (10% max cap): \$324,721

HOME: CHDO Development Set-Aside (minimum 15% of annual allocation): \$554,300

HOME: CHDO Operating (3.4%): \$184,767

HOME: Non-CHDO Affordable Housing Development (80.7%): \$4,439,740

ESG: Administration (7.5% max cap): \$43,678

ESG: Homeless Housing and Services (92.5%): \$538,696

HOPWA: Administration (3% max cap): \$93,380

HOPWA: Project Sponsor Allocations (97%) \$3,234,869
