Presentation(s): Rachel Weinstein, Elder Source, Community Outreach and Caregiver Coalition Coordinator, informed the CPAC about the programs offered through Elder Source.

Elder Source is a nonprofit organization designated by the State of Florida. Elder Source works with local, state and national partners to advocate on behalf of older adults and their needs.

Locally, Elder Source works with agencies to help provide congregate dining and home delivered meals, senior center programs, legal assistance, senior center programs, adult daycare, in-home services, consumer protection issues, minor home repairs, support for caregivers, health and wellness programs.

Additionally, SHINE (Serving Health Insurance Needs of Elders) is a program of the Florida Department of Elder Affairs and is operated in this area through Elder Source. SHINE offers older adults, adults with disabilities and their caregivers free counseling on Medicare and insurance issues. SHINE can be contacted at 1-800-96-ELDER.

Elected Officials Report:

Joe Johnson, Executive Council Assistant, District 11 – on behalf of Council Member Becton, Mr. Johnson provided the following updates:

- Council Member Becton is following Ordinance 2023-0069, which seeks to rezone 6,174 acres
 east of I-295 in the general area of e-Town. If you have any questions or concerns regarding this
 development, please contact Council Member Becton.
- FDOT is scheduled to start a re-paving project on Southside Boulevard this summer.
- FDOT will also complete several intersection projects along Southside Boulevard. Those
 intersections include Southside Boulevard and Deerwood Park; Southside Boulevard and Belle
 Rive Road and Southside Boulevard and Paradise Island Boulevard.

Staff Reports:

JSO – Assistant Chief Glossman provided an overview on Ordinance 2022-574; also known as the Pedestrian Safety Law. This new law prohibits: the use of the public rights-of-way in a manner that interferes with the safe and efficient movement of people and property from place to place on a public road. Any person to stop, stand, or otherwise occupy or remain in a median on any designated roadway when that person is not in the process of lawfully crossing the road; any physical interaction between a pedestrian and an occupant of a motor vehicle, including but not limited to the transfer of any product or material, while the motor vehicle is not legally parked; any use of public right-of-way for commercial activity.

Penalties for violations include:

- First violation, will be an official warning with an educational notice from the Sheriff's Office
- Second violation, the offender will also be given an official warning and may be trespassed.
- Third violation, a civil citation may be issued.
- Fourth violation, the offender may be arrested or given a notice to appear, as applicable, with a maximum of 10 days penalty if the violator is arrested and convicted.
- Additionally, each incident occurring more than every twenty (20) minutes after the violation has been corrected shall constitute a separate violation.

Soon, JSO will implement a 30-day education campaign to ensure everyone understands the new legislation. After the educational campaign has been completed, enforcement will begin.

ReadiRide is a service offered by the JTA that provides affordable, on-call transportation to customers in 14 Jacksonville communities. Municipal Code Compliance Division –Robert Bautochka Zone 3 Supervisor, stated in the past 30 days, 875 inspections were completed and year to date 3034 inspections were completed in the Southeast District.

The Jacksonville Assistance and Relief or JAR program was reviewed. The purpose of the Jacksonville Assistance and Relief Program is to facilitate a means of compliance to those who would otherwise be

unable to achieve it due to disability or economic disadvantages. The program's objective is to provide the abatement services required at no cost to those citizens who qualify, thereby achieving compliance and beautification of the city while not unduly burdening its most vulnerable citizens.

Subcommittee/Liaison Reports (3-minute time limit):

LUZ- Craig Shoup – stated the subcommittee reviewed seven new LUZ applications and no motions or actions were made.

North Florida TPO – Jim Hill – stated that the NFTPO reviewed the a list of priority projects. There are two funded projects in the Southeast district and both projects are currently under construction. Both funded projects are intersection improvement projects that are located at:

- The interchange at San Pablo Road and J. Turner Butler Boulevard (S.R. 202)
- The interchange at Kernan Boulevard and J. Turner Butler Boulevard (S.R. 202).

Unfunded projects were also discussed, such as:

- Beach Boulevard (between Parental Home Road and St. Johns Bluff Road) pedestrian safety and intersection improvements have been identified for a future project.
- An intersection improvement project at San Jose Boulevard (S.R. 13) and I-295 is expected to be funded and construction to begin in 2024.

Park Safety Council – Walter Bryant informed the CPAC that the Park Safety Council met earlier today, and they had a very brief meeting; a quorum was not present. A Park Safety report was not provided to the council members; a few comments were shared with those in attendance and the meeting adjourned. TRUE (Taxation, Revenue, and Utilization of Expenditures) Commission – Ramon Day stated at the February TRUE Commission meeting, city auditors presented on six of their eight reports. The two remaining reports will be presented at the March meeting. From the audit presentations, it was determined that overall, the various independent authorities (JTA, JAA, JPA, JTA) and various departments are operating within their budgets. A few financial incidents occurred, were identified, and should be rectified.

- In October, CPAC's will celebrate their 30th Anniversary. To commemorate this milestone, there was a request for any CPAC memorabilia, especially items, pictures, or appointment letters from the 1990's.
