#### Call to Order/Verify Quorum:

Vice Chair Shoup called the SE CPAC meeting to order at 6:30 pm and welcomed everyone to the meeting at the Mandarin Senior Center and on Zoom. Rosemary Wesolowski verified that a quorum was present.

**Approval of the Previous Meeting Summary** – The January 2024 meeting summary was approved.

**Presentation(s): Barabra Wingo, President, Norman Studios Silent Film Museum, Inc.** informed the CPAC about the history of the silent film industry and the revitalization of the Norman Studios Silent Film Museum.

In the early twentieth century, for a brief period of time, Jacksonville Florida was dubbed the Winter Film Capital of the World. Many silent film studios set up shop locally. In 1916 in the Arlington area, Eagle Film City was formed. In the early 1920's this studio was purchased by Richard E. Norman and became known as Norman Laboratories. Norman Laboratories released films under the name Norman Film MFG and Norman Studios. Mr. Norman's films were among the nation's first to produce race films starring African American characters in positive, non-stereotypical roles.

Norman Studios consisted of a five-building complex located at 6337 Arlington Road and is the sole silent film studio remnant from Jacksonville's heyday as the Winter Film Capital of the World. Several silent movies were made at Norman Studios between 1920 and 1928; several of the films were filmed entirely on the property.

After the cameras stopped rolling at Norman Studios, the property would become known as the Gloria Norman Dance Studio, which operated at this location from 1935 to 1976. In the 1990's an Arlington preservation group was formed, to help save the historic, but rapidly deteriorating film/dance studio buildings. In 2002, the City of Jacksonville purchased four of the five original buildings and stabilization of the buildings and restoration on the exterior of the buildings was completed in 2007. Recently, the City of Jacksonville was able to purchase the fifth building which was the original set/stage building, thus reuniting all the original buildings. This newly acquired building was recently unanimously voted by Jacksonville City Council to be named the Rita F. Reagan Building to honor the longtime preservationist and Norman Studios Silent Film Museum co-founder. The efforts of Old Arlington Inc, and Ms. Reagan were validated when the studios and property were designated a National Historic Landmark by the National Park Service in 2016.

# **Elected Officials Report:**

George Foote, City Council District 5 Executive Council Assistant, provided the following updates:

- The San Marco trashcan installation project is scheduled to take place on March 4, 2024.
- Tree installation in the medians along Baymeadows Road has been approved.
- At the state level, legislation has been introduced to make it illegal for people to sleep on public property. This includes sidewalks, city parks and right of way areas.
- FDOT is conducting underwater work near the John T. Lowe Boat Ramp at Goodby's Creek and has been using the parking lot in the park as a staging area; the FDOT project should be completed in March.
- Mr. Foote and a Public Works team member will work in the field to assess curbs, storm water and flooding in Council District 5.
- Councilmember Joe Carlucci is still waiting on a quote to have a water line installed on Wright Avenue in the Pine Forest community.

#### **Staff Reports:**

**JSO - Assistant Chief Glossman**, shared the following updates from JSO:

- In the last 30 days in the Southeast District, crimes against persons were up by 20 incidents. Crimes against persons include the following categories, murder, manslaughter, kidnapping, abductions, all sexual offenses, robbery, aggravated assault, and simple assault. JSO has made a sizable number of arrests in this category.
- In the crimes against property category, District 3 is down by 10 incidents.
- Motor vehicle thefts increased by 16 incidents. This is attributed to the thefts of Kia and Hyundai vehicles. If you own one of these brands of vehicles, please take the vehicle to a local dealer to get a software update.

**JFRD - Captain Ben Kodatt,** introduced himself to the CPAC and provided the following recommendations:

- If you need assistance to check and/or change the batteries in your smoke detectors or need a smoke detector, please call 630-CITY or enter your request online using the MyJax system.
- A new Marine Fire Station was opened today (February 26, 2024) on Scott Mills Road, just north of I-295.
- JFRD will complete their annual inspections of the local fire hydrants in February. It was confirmed that JFRD inspects the fire hydrants, but the fire hydrants are owned and maintained by JEA.
- There is a year-round ban on burning trash. The only types of open fires that are allowed in Duval County are small recreational fires in a firepit and a fire in a bar-b-que pit and/or smokers for cooking purposes.

# Parks, Recreation and Community Services – Jackie Gregson stated:

- Several of the swimming pools are being renovated; renovations at the Pine Forest swimming pool were completed a couple of months ago and the Englewood swimming pool is under major renovation. The swimming pool at Wolfson High School is in good shape and is ready to open in May.
