I. CALL TO ORDER

Chair Newby called the KingSoutel Crossing Community Redevelopment Agency (KSC/CRA) Board meeting to order at approximately 4:01 p.m. A quorum was confirmed.

II. ACTION ITEMS

APPROVAL OF THE FEBRUARY 8, 2022 KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT AGENCY (KSC/CRA) BOARD MEETING MINUTES

A MOTION WAS MADE AND SECONDED APPROVING THE FEBRUARY 8, 2022 KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT AGENCY BOARD MEETING MINUTES. THE MOTION PASSED UNANIMOUSLY 13-0-0.

KSC/CRA Agency Board Members D. Becton, J. Pittman and R. Diamond arrived at the meeting after the approval of the KSC/CRA February 8, 2022 Meeting Minutes.

CONSIDERATION OF THE KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT AGENCY FY 2022/2023 PROPOSED BUDGET (RESOLUTION KSC/CRA-2022-02)

Mr. Wendland made a general comment related to the FY 2022/2023 Proposed Budgets for all three of the CRAs. He noted that the budgets are preliminary and still need to go through the MBRC process, Finance Committee and City Council, adding that the Agency Boards will see the budgets again. He noted at this time there are some consistent themes with all three CRA Budgets in that the Property Taxes are showing flat but should increase. At this point, we do not have any preliminary valuations to make the adjustments. He commented that the only thing we would originally commit

to is Administrative Expenses (\$95,565) and the remainder would go into the Unallocated Plan Authorized Expenditures (\$1,507,520), which means decisions for those dollars would be made after October 1, 2022.

Mr. Wendland summarized the FY 2022/2023 KSC/CRA Proposed Budget

Property Taxes: \$1,575,217 Investment Pool Earnings: \$27,868 Total Revenues \$1,603,085

Chair Newby opened the floor for public comment of which there was none.

A MOTION WAS MADE AND SECONDED TO APPROVE THE KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT AGENCY BOARD RESOLUTION KSC/CRA-2022-02 ADOPTING A FY 2022/2023 PROPOSED BUDGET. THE MOTION PASSED UNANIMOUSLY 16-0-0.
