



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5823-23C was filed on August 16, 2023, as Ordinance 2023-533.

The subject site is approximately 3.08 acres and is located with an address of 6826 Richardson Road, between New Kings Road and Richardson Road.
