



Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5840-23C was filed on April 3, 2024, as Ordinance 2024-275.

The subject site is approximately 17.81 acres and is located with an address of 0 Pritchard Road and 6453 Robinson Road, between Interstate-295 North and Pickettville Road.
