

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application <u>L-5840-23C</u> was filed on <u>April 3, 2024</u>, as <u>Ordinance 2024-275</u>.

The subject site is approximately <u>17.81 acres</u> and is located with an address of <u>0 Pritchard Road and 6453 Robinson Road</u>, between Interstate-295 North and Pickettville Road.

The current land use category is <u>Low Density Residential (LDR)</u>. The proposed land use category is <u>Light Industrial (LI)</u>. Plan category descriptions can be found on the Planning and Development Department website.
