



## **Notice of Public Hearing for Proposed Land Use Change**

Small-scale land use amendment application L-5846-23C was filed on September 20, 2023, as Ordinance 2023-652.

The subject site is approximately 3.61-acres and is located with addresses of 1105 Grant Street, 0 Grant Street; 0 Spratt Street; 0 Van Buren Street; 0 Albert Street; 0 Georgia Street, between Grant Street and Albert Street.

The current land use category is Medium Density Residential (MDR). The proposed land use category is Community/General Commercial (CGC). Plan category descriptions can be found on the Planning and Development Department website.
