



## **Notice of Public Hearing for Proposed Land Use Change**

Small-scale land use amendment application L-5849-23C was filed on September 20, 2023, as Ordinance 2023-654.

The subject site is approximately 3.94 acres and is located with addresses of 8533 Malaga Avenue and 3700 Collins Road, between Collins Road and Carmona Street.

The current land use category is Low Density Residential (LDR). The proposed land use category is Recreation and Open Space (ROS). Plan category descriptions can be found on the Planning and Development Department website.
