Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-5892-23C was filed on March 6, 2024, as Ordinance 2024-192.

The subject site is approximately 4.31 acres and is located with an address of 0 New Kings Road and 10042 New Kings Road, between Trout River Boulevard and Barth Road.

The current land use categories are Heavy Industrial (HI) and Low Density Residential (LDR). The proposed land use categories are Light Industrial (LI), Business Park (BP), and Community / General Commercial (CGC).
