

## Notice of Public Hearing for Proposed Land Use Change

Large scale land use amendment application L-6018-25A was filed on July 16, 2025, as Ordinance 2025-483.

The subject site is approximately <u>344.60 acres</u> and is located at <u>0 Butch Baine Drive, northwest of the intersection of I-95 and Pecan Park Road.</u>

The current land use category is <u>Agriculture (AGR), in the Rural Area</u>. The proposed land use categories are <u>Low Density Residential (LDR) and Conservation (CSV), in the Suburban Development Area</u>. Plan category descriptions can be found on the Planning Department website.

#### PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS

- Timeframe set by Host No more than 3 minutes per speaker.

- Host will **ONLY** recognize speakers that use the **ELECTRONIC** "**RAISE HAND**" feature located within the Zoom App \*9 ... wait to be recognized. (Must have a Microphone and Speakers on phone to participate with the function.)
