

Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-6043-25C was filed on July 16, 2025, as Ordinance 2025-487.

The subject site is approximately <u>2.29 acres</u> and is located with an address of <u>11153 Beach Boulevard</u>, <u>between Cortez Road and Desalvo Road</u>.

The current land use categories are <u>Low Density Residential (LDR) and Community/General Commercial</u> (<u>CGC</u>). The proposed land use categories are <u>Light Industrial (LI) and Community/General Commercial (CGC)</u>. Plan category descriptions can be found on the Planning and Development Department website.

PHONE CONTROLS FOR DIAL-IN PHONE ONLY PARTICIPANTS

The following commands can be entered via phone tones using your phone's dial pad while in a Zoom meeting:

- Host will **ONLY** recognize speakers that use the **ELECTRONIC** "**RAISE HAND**" feature located within the Zoom App *9 ... wait to be recognized. (Must have a Microphone and Speakers on phone to participate with the function.)
