

## Notice of Public Hearing for Proposed Land Use Change

Small scale land use amendment application L-6054-25C was filed on July 16, 2025, as Ordinance 2025-491.

The subject site is approximately <u>0.37 of an acre</u> and is located with an address of <u>2939 Manitou Avenue</u>, <u>between Ortega Boulevard and Baltic Circle</u>.
