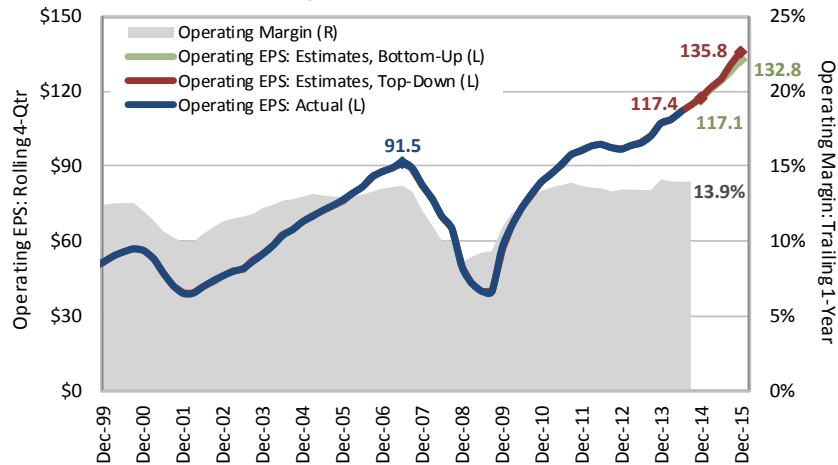

Rolling 4-Quarter, Actual and Estimated



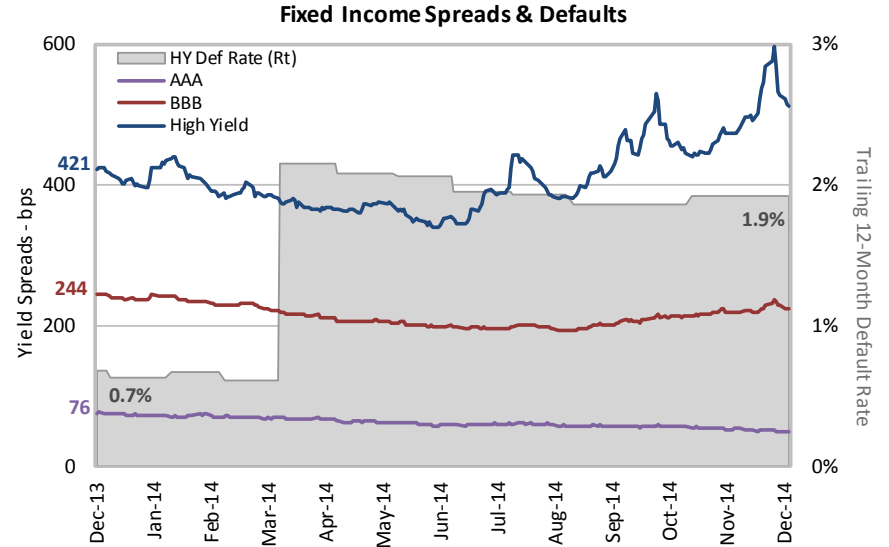
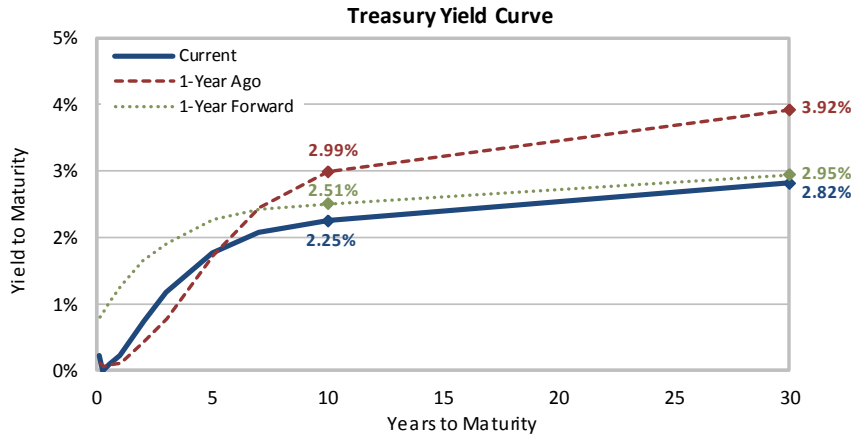
