3. Call for Public Speakers (online & card):

a) John Nooney - (Public Speaker) Expressed his concerns regarding his trespass citation on Jacksonville University property (seeking pardon), and river access. Continues to lobby for the purchase of his property by Potsburg Creek.

- a) Pat Andrews- (San Marco Preservation Society) Details the popularity of the park and need for its upgrade Seeks to encourage the approval of the plan as presented.
- b) John Johnson- (Parks landscape architect) Details issues related to the park location and how the plan best works for the park. Fraser: Asked questions regarding drainage and type of "shade" trees selected. Powell [audience member]: Would like to see options in trees other than palms to be planted, expressed concerns related to townhome views related to the selection of trees to be planted.

The presenter explained aspects of the planting project in relation to the bulk head tie backs and how this infrastructure affected the choice of tree species in the design. Also, the presenter explained that community involvement was part of the planning process.

a. Combined revenues: Combined Revenues for Fiscal YTD are \$4.91M compared to \$3.43M Apr-24. An increase of \$1.48M year-on-year. Combined Expenses for Fiscal YTD are \$2.35M compared to \$3.58M on Apr -24. A decrease of \$1.23M yearon-year. Combined Revenues for Apr -25 were \$1.13M compared to \$551.9K for Apr -24, an increase of \$576.8K. Meanwhile, expenses were \$425.2K and \$404.6K on Apr -25 and Apr -24, respectively. Total unallocated funds were \$25.21M for Apr -25.

9. Requested follow-up from previous meeting: Taken out of order Follow up on Remove and Replace funds request legislation (bill number 2025.324) moved as emergency and was passed unanimously.

Question from audience member, Nancy Powell, regarding why use of the emergency passage process for the bill was applied. MacGillis explained that a "1-cycle" emergency process was used, which is a three week process to include a full Committee week (Finance and TEU) of review versus the full six week cycle. MacGillis explained that a 1-cycle emergency passage was requested in order to get the funds to the account as soon as possible, but with Council standing committees' review. Powell expressed displeasure that the fund was not replenished earlier (so as to not need an emergency). The fact of the cancellation of the April meeting was acknowledged.

11. UFMP Update: Valerie Feinberg:

(UFMP presentation available in supporting documents) Presentation overview detailing what the UFMP and their three workshops with different groups to be presented at Tree Commission May 16th UFMP Workshop presentation.

Fraser: When is the next deliverable? Feinberg: That date will be determined in a meeting this afternoon. Powell: Is there going to be a defined Urban Forest Management Plan? Feinberg: This is being developed.

12. Old Business

A. Taskforce Update- Fraser: request for extension of taskforce. MacGillis stated that she will present the request to the Chair for his approval of extension to taskforce. MacGillis stated to expect an Amended Charge Memo on the topic soon, and that it will be distributed and posted to the website.

13. New Business:

i. 2025-0102-E, an ordinance by Council Member J. Carlucci, signed into law on April 18, 2025. Sickler: Staff addition authorization included in legislation, more measures are part of the process before these new positions can be posted for availability. McDaniel: These positions will need to be created then brought to the tree commission for approval to fund. MacGillis: Getting new positions to Tree Commission to make a recommendation is a multi-step process requiring the positions to exist first (the creation of the positions are park of the budget ask from Public Works, then the positions can be brought to Tree Commission, then the recommendation for the positions to be funded by Tree mitigation funds is presented in the form of legislation to City Council).

Sickler: next meeting would be the time to bring a package with specific details on positions and dollar amounts for requests.

ii. Mowing in City Parks: Fraser: Expressed concerns regarding trees being damaged by mowing subcontractors multiple times after contractors have been warned. Suggested trees have mulch tree rings or protective guards included in install. McDaniel: Asked if there be a separate tree string trimming option? Currently contractors have had maximum contract repercussions, but this has not remedied the issue. Additional factors include the turnover of subcontractors and lack of regular quality workers due to the nature of the work. **Fraser**: Suggested use of neighborhood groups to help with maintaining tree bases. **McDaniel**: Expressed that any help offered by these groups is welcome and appreciated. Tree rings and guards are suggested to resolve the issue.

The City of Jacksonville has two separate laws that provide protection for certain trees and require mitigation for damage or removal of certain trees caused by the process of land development. Mitigation is required either through planting or replanting of a calculated amount of mitigation trees or through making a specified payment into the Tree Protection and Related Expenses Trust Fund codified by Sec. 111.760, Ordinance Code. These laws are Article 25 of the Charter of the City of Jacksonville and Chapter 656, Part 12, Subparts A & B of the Ordinance Code. Each provision has specific criteria for what is characterized as a "protected tree" and thus would require replacing through the development process of a site, or if a replacement is not made, how the "mitigation fee" is calculated for removal of trees without replacement. The mitigation fee that is paid by developers who are unable to replace the trees destroyed during construction, as required by both provisions, is placed in the Tree Protection and Related Expenses Trust Fund. Moreover, funds received from application of the Charter are held in Fund 15305 and funds received from application of the Ordinance Code are held in the Fund 15304.

<u>Alexandria Oaks Park</u>

This is a proposed Level 2 Tree Planting designated for City of Jacksonville Alexandria Oaks Park at 1620 Marco Pl. This is a proposed 18-22" DBH specimen Live Oak installation to be designated at the 'Centennial Oak" as part of the 100 tree planting challenge given by the Council President and would also commemorate the 100th anniversary celebration for San Marco. The site has been review with JEA and Park's staff for feasibility and impacts. The location was determined based on the ease of access and lower impact on existing infrastructure. The planting would include extended maintenance and warranty based on the substantial cost of the tree and the risks of transplant of a tree of this size. Irrigation is included in installation as well as monitoring of the irrigation system for the extended length of the warranty. Scheduled monitoring of the tree with regard to health and watering will be included in the scope of work.

Some of the Tree Commission's duties include acting as a coordinator for programs, projects, and activities related to planting projects and the health of the tree canopy between all public and private entities and to review expenditure proposals and plans for planting projects.

The Commission was established by the City Council enactment of 2017-397-E on July 25, 2017. Meetings are held on the third Wednesday of each month. The first meeting of the fiscal year 2024 for Tree Commission was held October 19, 2023.

In Fiscal Year 24, the Commission has:

- Received \$6,811,658.13 in Tree Mitigation Fund Revenue.
- Spent \$5,947,819.25 on planting trees and warranties.
- Planted 3,246 Trees using the Tree Fund of which only 4% were palm trees.
 - Approved ten Level 2 Tree planting projects for a total of 12,605 trees. 12,000 trees were apart of one project, McGirts Creek, where seedlings are being planted.
 - Planted 225 trees with the 630-CITY Planting Program where constituents may call in and request trees be planted in their public right-of-way.
 - Planted 939 trees with the remove and replace program, where dead, dying, hazardous trees are removed and planted with a healthy new tree.
