INSTRUCTIONS FOR PUBLIC PARTICIPATION IN PUBLIC COMMENT PERIOD DURING MEETING:

1. All participants who wish to participate in public comment during the meeting will state their intention and provide their full name.
2. The Chair will establish a time period for each speaker that is no more than 3 minutes per speaker.
3. Speakers will wait to be recognized for public comment time period by the Chair.
4. The Chair will call on speakers, by name, from individuals requesting to speak.
5. The speaker will begin speaking after the Chair has recognized the speaker's turn during the public comment period. The speaker will remain within the established time period.
