Meeting Summary

- **1.** Call to Order and Verify Quorum Chair Darby called the meeting to order at 9:31 am and verified that a quorum was present.
- 2. A Moment of Centering Chair Darby asked for a moment of silence in observance of 9-11 victims. Shen then read a quote which noted that Human Rights are things to fight for and protect, not just enjoy.
- 3. Approval of Agenda The September 10, 2025, Agenda was amended as follows: The Presentation was made by JEA Staff, Lisa Jennings, Project Outreach; Greg Corcoran, Community Outreach and Mike Williams, Program Manager. Mr. Phil Perry, City of Jacksonville, Chief Communications Officer/Public Affairs, will present at a future meeting. Change also the Next Meeting Date to Wednesday, October 8, 2025.

The Meeting Agenda was approved as amended.

- **4. Approval of the Previous Meeting Summary** The August 13, 2025, meeting summary was approved.
- 5. Presentation: JEA Staff Lisa Jennings, Project Outreach; Greg Corcoran, Community Outreach and Mike Williams, Program Manager provided an update of the Riverview Community Septic Tank Phase Out (STOP) Program progress and distributed STPO informational materials:
 - Project Objectives The City of Jacksonville, working in partnership with JEA, initiated a program designed to eliminate failing septic systems. The program involves the installation of new sewer and water infrastructure where none currently exist in the city's opened and maintained rights-of-way. It will also include proper abandonment of existing septic tanks, and the installation of individual sewer and water lines on private property and connection to the new JEA sewer and water systems. Utilities installed under this program will include payment of all associated permits and fees associated with sewer and water connection at no cost to the property owner. JEA will manage the

- outreach, engineering and construction of the project and operate and maintain the sewer and water systems once they are installed.
- Property Owner Participation The City of Jacksonville Ordinance requires the
 consent of at least 70 percent of the legal property owners identified within the
 Riverview property boundary. After that threshold has been met, the city and JEA will
 move forward with the project's design, engineering and construction. If the project
 does not achieve the required 70 percent minimum approval, the neighborhood will not
 be eligible for program funds for at least five years.

- **6. Mayor's Staff Updates** Pat McCollough, Special Assistant to the Mayor on Civic Engagement and Youth Participation:
 - Ms. McCollough thanked the Board for the work they are doing and for how well they
 represent the city and Mayor Deegan. She encouraged them to continue their
 efforts.
 - She discussed the Mayor's upcoming Budget Town Hall Meetings and encouraged board members to attend.
 - Ms. McCollough noted that the announcement regarding the Civil Rights Trail designations will come at the end of October 2025.
 - She is continuing with the Legacy Project remaining markers process and invited members of the MAAAB to participate.
 - The Mayor's Young Leaders Advisory Council had more than 200 applicants to fill 50 seats. They identified their top three priorities: Mental Health, Employment and Homelessness.
 - Chair Darby will recommend either the Program Committee or the Arts & Culture Committee to participate on the Legacy Trail Project. An invitation will be extended to the Youth to attend the November 12, 2025, MAAAB Board Meeting at the Legends Center, at 6 pm.

7. Public Comments & Announcements (three-minute limit)

- Dr. Lynn Sherman, Director of Health Programs expressed an interest in making a presentation to the Board. She will coordinate with Ms. Henry to schedule.
- Ms. Dana Maule announced an exhibit at the Ritz Museum on September 21, 2025, at 2 pm: Seven Local legends Through Arts. She also announced an event on September 27, 2025, at 9 am, to be held in Durkeeville.
- **8.** Chair's Report Dr. Darby attended the following meetings:

 - September 3, 2025 City Council Budget Hearing
 - Chair Darby also indicated that, as a private citizen, she wrote a letter expressing
 her views on the budget and she encouraged other board members to do likewise, if
 so inclined
 - Lastly, she encouraged board members to attend the budget town hall meetings.

- Arts & Culture Committee Chair Dawn Curling Excused absence.
- **Economy & Infrastructure** Next Meeting: September 16, 2025.
- Health & Public Safety Next Meeting: September 9, 2025.
- Military & Veterans Affairs Met on August 25, 2025, and discussed the following with Harrison Conyers, Director of Military and Veterans Affairs; Tiffany Morales, Veterans Outreach Manager and Clarance Harper, Veterans Outreach Coordinator:
 - Homeless and At-Risk Veterans The Military and Veterans Affairs (MAVD)
 Department has partnered with JFRD to identify and provide services for local homeless individuals. The MAVD placed 72 homeless veterans in short term housing in 2024 and is currently providing the same services in 2025.
 - The Veterans Resource Portal The MAVD is currently in talks with the COJ Technology Support Office to create a Resource Portal which will house service organizations and resources for public view and service organizations will be able to support and tract veterans via the portal.
 - Community Center The MAVD has received funding for the planning of the COJ Veterans Center which will be located on Hogan Street in the Cathedral district. The projected start date for construction of the center is 2027.
 - Veterans' Memorial Wall Upgrade The upgrade is estimated at \$6 million, with a digital overhand, new lighting and speaker system and fans.
 - The Jacksonville Urban League (JUL) Veterans and Community Empowerment Center (CVEC) – The Jacksonville City Council Finance Committee removed the CVEC from the Mayor's 2026 projected budget, and the JUL pivoted the center to a Community Empowerment Center.
 - On September 18, 2025, the MAAAB Military & Veterans Committee will attend the Veterans Council of Duval County and will continue to engage with community partners and veterans organizations.
 - Pat McCollough will forward information on the 250 Anniversary of the Military Event
 - Revised recommendations to the MAAAB were submitted for review and discussion/approval.
 - The next MAAAB MVA Committee Meeting will be held on November 18,
 2025, at 6 pm at the Main Public Library.
- **Program Committee** Met on August 13, 2025, and submitted three recommendations to the Board:
 - Expand support for minority-owned businesses navigating the JSEB Process.
 - Advocate for increased funding for Youth Workforce Initiatives through corporate collaboration.
 - Partner with civic organizations to conduct an African American Quality of Life Study in Jacksonville.
 - The next Program Committee is scheduled for October 13, 2025. (NOTE: meeting has been rescheduled for October 27, 2025).

Chair Darby would also like to draft a Press Statement and forward it to Phil Perry, COJ Public Affairs Office for review.
 - It was properly moved and seconded that the board will pursue a Press Statement to outline its position on the information noted above relative to the 2026 budget.
 - The board welcomed Conrad Jennings as its new board member. His date of appointment is August 15, 2025. He works for the CSX Corp and is from Texas.
