MAAAB Staggered Terms

Pursuant to Executive Order 2024-02, Section 3., the Mayor's African American Advisory Board shall consist of eleven (11) members.

Each member shall be appointed by and serve at the pleasure of the mayor. The members of the Board shall serve for terms of four (4) years.

Of those members initially appointed:

- Three (3) members shall serve two (2) years
- Three (3) members shall serve three (3) years
- Five (5) members shall serve four (4) years

Board Member shall serve no more than two (2) consecutive terms. For purposes of reappointment, the initial appointment shall count as a full term and the initial appointees may be reappointed for one (1) additional term thereafter. A vacancy shall be filled for the remainder of an unexpired term in the same manner as the original appointment.
