Executive Summary

On July 18, 2025, a City of Jacksonville (COJ) Right of Way & Stormwater Maintenance (RWSM) Division employee contacted the Jacksonville Sheriff's Office (JSO) and reported that two concrete saws and two chainsaws were missing from COJ storage at 2637 1st Street West in Jacksonville. On August 26, 2025, a maintenance supervisor for the division contacted JSO to report a burglary that occurred at the same location. Two additional concrete saws were stolen. The six missing and stolen items totaled \$4,000.00.

On August 28, 2025, a COJ employee was arrested for attempting to sell a concrete saw with a serial number matching one of the reported items.

The incidents above prompted the Office of Inspector General (OIG) to review the RWSM equipment inventory policies and procedures. A supervisor for the division advised RWSM did not have any existing policies or procedures regarding inventory.

Background

On July 18, 2025, Robert Ratcliff, an employee with the City of Jacksonville (COJ) Right of Way & Stormwater Maintenance (RWSM) Division, contacted the Jacksonville Sheriff's Office (JSO) to report four items that were missing from a COJ storage building at 2637 1st Street West in Jacksonville. The missing items included two STIHL concrete saws (valued at \$700 each) and two STIHL chainsaws (valued at \$300 each). According to the report, management was unable to determine whether the items were lost, left at a job site, or stolen. Serial numbers for the missing items were provided to police. (See JSO Incident Report 2025-0411950.)

On August 28, 2025, SWDD's supervisor, James Halloway, contacted JSO to report a burglary at the same location. Halloway reported that sometime between August 26, 2025 and August 28, 2025 an unknown subject gained access to the building, cut two padlocks on an equipment locker, and stole two additional STIHL concrete saws (valued at \$1,000/each). Serial numbers were provided to the police.

(See JSO Incident Report #2025-0496803.)

At approximately 11:00 pm on August 28, 2025, JSO arrested COJ Parks Department employee Floyd Lee Dixon for attempting to sell one of the chainsaws for \$450. Detectives were able to confirm that the serial number on the saw matched one of the saws reported stolen. He was charged with one count of dealing in stolen property. (See JSO Arrest and Booking Report 2025-018667.)

The incidents above prompted the OIG to review the RWSM's official policies concerning inventory and reporting lost or stolen items. Maintenance Supervisor Tim Taylor was interviewed. Taylor explained he has completed department-wide inventory checks of all small engine equipment items (including saws, generators, pumps, weed eaters, and leaf blowers) twice per year in all four zones (North, South, East, and West) for the last 20 years. He physically inspects each item and notes its serial number as it is accounted for. There is no policy detailing any inventory practices, but he records each inventory on an Excel spreadsheet. He provided copies of the 2024 and 2025 inventory spreadsheets to the OIG for review.

Taylor advised that after the October 2025 inventory was completed, one additional chainsaw was stolen from a locked box on an employee's vehicle on October 13, 2025. The item was valued at \$429.99. All other items were accounted for. (See JSO Incident Report # 2025-051293).

Taylor noted that he will be retiring in May 2026 and strongly suggested that the RWSM adopt a policy detailing inventory procedures for the next incoming supervisor.

Allegations, Governing Directives, and Findings

Florida Statute 812.014 Theft Florida Statute 812.019(1) Dealing in Stolen Property

No COJ policies or procedures relating to equipment inventory were violated.

Recommended Corrective Actions

It is strongly recommended that the City of Jacksonville's Right of Way & Stormwater Maintenance (RWSM) Division adopt a policy detailing inventory procedures and the reporting of lost, damaged, or stolen items. An updated inventory system that can be readily reviewed by those with oversight responsibilities should also be established.

The employees interviewed by the OIG and JSO stated that the camera systems were not operational at the alleged times the items were stolen, and that the lighting in those areas is extremely dark overnight. Therefore, it is also recommended that the division improve lighting and camera systems in areas where motorized equipment is stored.

Management's Response

The Right of Way & Stormwater Maintenance (RWSM) Division has a small equipment policy (15 in our Policy Manual) that was developed before 2001. An updated Department Policy Memorandum was drafted in July 2010 but was not officially distributed. However, the RWSM Division's current control activities incorporate several elements to address issues identified in the policies. Our equipment control section maintains a spreadsheet tracking of all small equipment within the Division, including make, model, serial number, division identification number, and assigned location. Each Superintendent assigns specific equipment to their personnel for accountability purposes. Some equipment is shared among various crews based

on the maintenance task it supports. Maintenance areas are fenced and secured at the end of the workday. Inside these facilities, there are buildings with secure lockers for crew leaders to store tools, materials, and small equipment under lock and key.

Moving forward, the RWSM Division will review and clarify our processes and procedures to update Policy #15 "Security of Equipment" as appropriate, distribute the revised policy, and train personnel to ensure compliance. The Division will also identify recommended improvements to minimize the risk of loss, damage, or theft of division-owned equipment. Senior staff members are currently working with the Public Buildings Division to evaluate security concerns and identify measures to increase security at our West Area Maintenance Facility, focusing on exterior entry points, lighting, and security cameras.

On 7/18/2025 I spoke to Robert Ratliff (complainant) with the City of Jacksonville Streets and Drainage Department who advised his crew discovered the listed property missing on 7/15/2025, which was last seen on 7/14/2025. He advised the equipment is usually kept in a truck inside a fenced-in yard, and the gate is usually left open and unlocked due to the nature of the work performed. He advised the some of the security cameras in the area are non-working, and employees and management have been unable to determine whether the equipment has been lost, left at a previous jobsite, or stolen. He advised the value of the property is approximately \$2,000.00. He provided serial numbers and City of Jacksonville property numbers for each of the items. A search of Law Enforcement databases for these numbers yielded negative results, and as of the time of this report these items will be listed as "lost."

Additional Information

On 08-28-25 at 1359, I was dispatched to 2637 W 1st St in reference to a burglary to a COJ facility. Upon arrival, I contacted the complainant, Mr James Holloway (General Maintenance Supervisor).

Mr Holloway said that sometime between 08-26-25 (1530hrs) and this morning at 0800, an unknown suspect entered an unlocked tool storage building (2639 W 1st St) and stole two Stihl concrete saws. He said that they cut the padlocks to gain access to two separate storage cages that housed the saws.

I observed that this building has two separate garage doors that were up. Mr Holloway said that the doors are never closed after employees leave for the day. The property is surrounded on three sides by a 6' chain link fence (no barb wire on top) with a south facing roll gate. The north side of the property is not fenced and butts up to a wooded area. There are no operational cameras on this property, nor any nearby.

Mr Holloway did not know when or how the suspect gained access to the property. He did not know who may have done this, nor could he name any current or former disgruntled employees.

A pawn check was conducted, negative results.

No canvass was conducted due to this facility being surrounded by other COJ facilities without cameras.

A CSU detective was not requested due to the entire inside of the building being covered in dust and debris.

There are no further leads at this time.

Case not cleared - patrol efforts suspended.
