## **Meeting Summary**

- **1. Call to Order/Verify Quorum:** Chair Shumaker called the meeting to order at 5:30 pm. Edwina Henry verified a quorum was present.
- **2. Approval of Previous Meeting Summary:** CPAC Members approved the March 4, 2024, Meeting Summary, with a correction on page four: change dates of Veterans Affairs attendance at the Home and Patio Show from March 2 and 3, 2024 to March 22 and 23, 2024.
- **3. Presenters:** Marci Larson and Wiley Page, North Florida TPO Ms. Larson provided background on the North Florida Transportation Planning Organization:
  - The North Florida Transportation Planning Organization is established by Federal law to do regional transportation planning in four counties: Clay, Duval, St. John's, and Nassau Counties.

- The organization operates several committees: a Citizens Advisory Committee, a Technical Advisory Committee (comprised of engineers and transportation planners from the municipalities and counties that make up the NFTPO), and the decision-making body is the TPO Advisory board, a 15-member board made up of elected officials from the four counties, as well as the five transportation board members from the five transportation agencies (Jacksonville Transportation Authority, JAX Port, the Aviation Authority, the Regional Airport in St. John's County, and the Port in Nassau County.)
- One of the most important functions of the NFTPO is to develop a long-range transportation plan, every five years, with a twenty-year horizon.

- The website has a series of studies covering a variety of transportation issues, listed geographically, and based on available funding. There are currently 200 regional projects.
- Because community input on projects is extremely important, CPACs were asked to
  participate in a survey to indicate how they would like transportation dollars spent. North
  Florida TPO would like to know preferences for more bicycle, pedestrian facilities, more
  roadways, to have more roads widened, to see more technology, see more transit (transit
  meaning more than just buses), etc.
- Each person was asked to participate in the survey, and to encourage others to participate, as well. The survey will be open through the month of April. The website is <a href="https://www.2050pathforward.com">www.2050pathforward.com</a> – click on "updated survey."
- **4. Elected Officials Report:** The Honorable Darryl Willie, Schoolboard Member, Duval County Public Schools, gave the following report:
  - April is Celebrating Military Families Month. Schoolboard member Willie noted that
    Jacksonville has many military families whose children attend the schools, and the school
    district does whatever it can to ensure that it is a smooth transition for the students. He
    also acknowledged that he was a military kid, as his father was in the army. Duval County
    Public Schools has seven (7) Purple Star Schools, which signifies a school which has
    received exemplary marks for taking care of military families.
  - The Duval County Public School Board Building there were two offers being considered: JTA with a property in LaVilla and Florida Blue with a property in Riverside. The Board recently voted to not sell at this time but to leave all options and conversations open.
  - The Superintendent Search for Duval County Public Schools launched on March 15, 2024, and applications will be accepted through April 15, 2024. The semi-finalists will be selected from that group of applicants and narrowed down to the finalists. The Superintendent finalists will be in town on May 13 and 14, 2024, and there will be opportunities for the public to "meet and greet" the finalists. It is the desire of the Schoolboard to have the school Superintendent be selected by the community. Schoolboard member Willie also acknowledged Dr. Kriznar as the perfect person to have right now "to hold the ship steady to be ready to help transition the new superintendent and work with them to be able to start the new school year." It is the Schoolboard's goal to select the finalist by June and vote in July, and then have this person in place and ready to lead into the next school year.

  - Schoolboard member Willie discussed the changing landscape of education and the challenges facing "traditional" public schools. The board is discussing school consolidations and potential consolidations in many parts of the city. He wants the public

to know that there are no formal plans, only discussions by the school board as to possibilities. The public will have the opportunity to weigh in before any final decisions are made.

- **5. Chair's Report:** Chair Shumaker began his report by stating that the next CPAC Quarterly Chairs' Meeting is in May and asked if the membership had issues of concern they would like for him to raise to please forward those items in writing to the Neighborhood Coordinator.

- **6. Staff Reports:** Chair Shumaker reminded everyone that in the interest of time to keep remarks to three minutes.

**Neighborhoods Department** – Lisa Ransom, Neighborhood Services Manager on behalf of Thomas Waters, Director Neighborhoods Department, shared the following information:

- CommUniverCity, a free community leadership training program offered by the Neighborhood Services Office, starts Tuesday, April 2, 2024. The class is full at 45 participants, representing each of the six (6) planning districts, and hopefully some will pursue CPAC Memberships after completing their training.
- The Neighborhood Awards program is November 7, 2024, and applications have been sent out. The event will be held in the Main Public Library Auditorium, and it's open to the public. Each organization is encouraged to apply to highlight the amazing work and projects and other things each neighborhood/community completed in 2023. The evening is designed to be a great time of acknowledging and supporting all the hard work that happens, and how people make their communities wonderful places to live.
- The Situation Report is a list of outstanding issues that is shared with the mayor at the CPAC Chair's Quarterly Meeting. Just as Chair Shumaker requested, please forward your concerns to Edwina especially those concerns that have been entered into the MyJax system and be sure to include the tracking/care ticket number.
- The Urban Core CPAC used to meet in the Ed Ball Building first floor training room, prior to utilizing the Main Library. The Training Room has now been converted into a formal hearing room, utilized by a specific department, and may not be available for other uses. Therefore, the Urban Core CPAC will continue to meet at the Main Library, unless something else becomes available. Additionally, the Blight Subcommittee has been meeting in the Ed Ball Building on the fifth floor. That space is not open to the public after 5 pm, so the Blight Subcommittee will be meeting in the main library.
- Entering the Main Public Library from the Main Street Doors. The library has already stated that, it is not feasible now, to allow persons to enter from the Main Street doors due to budgetary and security concerns. The doors must be staffed by security personnel, and it is not in their budget to do so, so while it may be inconvenient for some, please cooperate and enter from the designated doors.

**FDOT** – Derek Dixon, Transportation Manager, responded to a previously submitted question by a CPAC member:

- A CPAC Member wanted to know if FDOT could improve the retention pond at the southeast corner of Pearl Street and Golfair, as well as remove the barbed wire on top of the fence. Dixon's response was that FDOT would not be making any changes to the pond in question. He also stated that he would contact their maintenance department, so the overgrowth problem should be taken care of.
- Mr. Dixon offered a statement on the collapse of the Key Bridge in Baltimore, MD The
  Florida Department of Transportation extends their deepest sympathies to those affected
  by the recent incident. FDOT also sends their sincere thanks to the first responders
  engaged in the search and rescue operations. Mr. Dixon went on to discuss the various
  methods used by FDOT to ensure the safety and integrity of the bridges in our State,
  including continuous coordination with local law enforcement, including the U.S. Coast
  Guard and Seaport Authorities to ensure comprehensive safety measures are in place.

- **JPL** Keli Likins, Executive Assistant II, Library Services, began her update with a comment about having CPAC Members enter through the library's back doors during library hours while the library is open.
  - The Main Street entrance is not a public entrance, so it must be staffed by security officers and the library did not budget for that this fiscal year. She also stated that the library is looking into whether they can find additional security officer funds added for the next fiscal year, however, she cannot make any promises.
  - Ms. Likins then wished everyone a Happy National Poetry Month. This April the library is having a porch-related program called a History Chat collecting Al and Justice. The program will highlight the life and poetry of Allen Justice, who lived from 1943 to 2011. He is a celebrated Jacksonville poet whose works have been recently acquired by the Jacksonville Public Library Special Collections. The program will include a talk about Justice's life and legacy, poetry, readings and a preview of an upcoming documentary about him. The date is Saturday, April 27 at 2 pm, upstairs in the Ann Spock or Map Room on the fourth floor.

**JFRD** – Captain James Groff stated that he did not have any new directives to share with the CPAC, but he is open to questions the CPAC might have.

• Captain Groff was asked about the extent of the electrical fire at the Hyatt Hotel. He was not aware of the incident and said he would investigate and report back. He stated that there's an official report for every fire.

**MCCD** – Chris Billings, Code Compliance Supervisor, gave the following report:

- Since March 4, 2024, MCCD has completed 1,230 inspections within the Urban Core.
- MCCD introduced a targeted systematic project in the 29<sup>th</sup> and Chase Neighborhood, resulting in 51 properties that were cited.
- The goal for the 29<sup>th</sup> and Chase Neighborhood was to focus on residentially owned properties to ensure uniform compliance and address issues that had typically gone unreported. Fifty-one properties were cited.
- A "ride through" was conducted in the Moncrief Neighborhood after MCCD received several
  complaints about excessive garbage, major automobile repairs, commercial vehicles, and
  abandoned properties. After assessing the area there were 200 potential code violations. A
  Moncrief targeted systematic is scheduled for May to help address some of the concerns.
- A corridor project is scheduled for April 16, 2024, starting from Main Street down to Eighth Street and up to Talleyrand. These inspections will target businesses, zoning issues and other ordinance violations.
- As a reminder, with spring underway, Municipal Code requires that all property owners maintain their property free of overgrowth vegetation, grass, weeds exceeding 15 inches in height to maintain their exterior properties free of trash debris, including yard debris.
- MCCD also inspects swimming pools, making sure that the pool, water quality and pool
  equipment are maintained and functional.
- MCCD is unable to always patrol all areas and therefore encourages and appreciates any help from citizens. He asked that property owners be vigilant with checking and maintaining their property and helping to notify MCCD of issues in their community.

- Mrs. Swain raised the issue that she has called 630-CITY a couple of times about stray dogs
  in her community, and nothing has been done. Mr. Billings responded that MCCD is not
  equipped to handle stray dogs and that Animal Care and Protective Services is the right
  department to respond. Mrs. Swain will forward her Care Ticket number to Ms. Henry for
  follow-up.

**JSO** – Lieutenant Jason Moore, Watch Commander, Zone 1, reported that:

- Year-to-date, violent crime is down in District 1 by 15%. Automobile theft is up within the district. He advises everyone to be sure to lock their car doors and set alarms, etc.
- Starting in April 2024, JSO will conduct "hotshot" deployments sending patrol units into areas where there have been multiple occurrences of violent crimes.

- 7. Old Business: Review feedback from the 2025-2029 Capital Improvement Plan (CIP).
  - Kathleen Collins, Capital Improvement Plan Administrator, returned the UC CPAC original submission with comments on the various projects that were listed and requested that the revised CIP be returned by April 30<sup>th</sup> to ensure it is presented to the Mayor's Budget Review Committee.
    - After discussion, a motion was made to adopt the changes as discussed and to revise the CIP letter and return it to Ms. Collins. It was properly moved and seconded. The motion carried.
    - Chair Shumaker made an amended motion to include installation of the pickleball courts to the revised CIP. The motion was properly seconded, and the motion carried.
- 8. New Business: None.
- 9. Subcommittees and Liaison Reports:
  - Governmental Affairs/LUZ Subcommittee Dimitri Demopoulos: the Subcommittee had
    one application to review. The subcommittee was hesitant to make a recommendation
    without knowing community preferences. The subcommittee passed a motion to
    recommend for approval the modification presented in MM-24-01 but with the condition
    that the perimeter chain link fencing be limited to 6 feet in height, in the hopes that it would
    spur discussion amongst the full CPAC.
    - Ms. Randolph, an Eastside Community Advocate, was invited to give comments on the proposal prior to the full CPAC taking a vote on the matter, to better inform the CPAC of what the neighborhood feels about the project.
    - Ms. Randolph stated that today was her first time hearing details about the project.
       Her feeling is that the developer needs to have a discussion with community
    - City Planner, Caroline Fulton, stated that the hearing for this application is scheduled for April 18, 2024, at 1 pm in the Ed Ball Building, Hearing Room, before the Planning Commission.
    - Ms. Randolph was encouraged by the CPAC to get community representatives to attend the hearing to voice their preferences. If they are unable to attend in person, they can provide a letter or a written statement to either our City Planner or the Subcommittee Chair.
    - Subcommittee Chair Demopoulos stated that if the community can be informed, and the people who are affected can inform the Planning Commission of what they would like, then maybe the subcommittee's motion should be withdrawn and allow the community to express their preferences.
    - Motion to recommend approval of MM-24-01 is denied.
    - Chair Shumaker took the opportunity to, once again, invite Ms. Randolph to join the
       CPAC as a representative from her community organization.
  - **Homelessness Subcommittee** Cory Haynes: First meeting is scheduled for Monday, April 29, 2024, at 5 pm. The Public Notice of Meeting will be emailed.
    - Mr. Haynes attended the Northwest Corridor Meeting and spoke with City Councilmember Jimmy Peluso who indicated the City Council recently voted on a Trust for Homelessness. Details to follow.

  - o Requested a report on what properties were given to nonprofits and when.
