## Call to Order/Verify Quorum:

Chair Koslowski called the SE CPAC meeting to order at 6:30 pm and welcomed everyone to the meeting at the Mandarin Senior Center. Rosemary Wesolowski verified that a quorum was present.

#### **Elected Officials Report:**

Jacksonville City Council, District 11 Council Assistant Evin Herzberg reported no real updates. Any questions or concerns should be directed to their office. District 11 had a Town Hall earlier in the month about E-Town. Council Member Arias is working with FDOT on traffic complaints at Nocatee Parkway and Phillips Highway.

#### Jacksonville City Council, District 11 Council member- Raul Arias reported:

- He addressed various traffic issues at the recent Town Hall meeting.
- The University of Florida and Jacksonville Small and Emerging Business (UF JSEB) program will meet on Monday, June 23, 2025, and will also meet this week to discuss small business development. UF will be building a campus downtown and plans to partner with small businesses to work on the centers and campuses being constructed.
- City Council will meet on Tuesday, June 24, 2025, to vote on the 45-million-dollar allocation of funds found by Council Member Matt Carlucci. Some of those funds will be used for workforce development, affordable housing, and downtown development.
- The Florida State College of Jacksonville's Downtown campus is at capacity. Once funding is available, they are hoping to expand to Cecil Field. Workforce Development funds will help train individuals in high-demand trades.
- He is working with the Parks, Recreation, and Community Services Department to install a dog park in the Fort Family Regional Park behind the tennis court and update the children's play area.
- The City Council's summer break is scheduled from Monday, June 30, 2025, through Saturday, July 12, 2025.
- Mayor Deegan will propose her budget on Monday, July 14, 2025. The City Council will focus on budgeting for the entire month of August 2025.
- He is actively working on requests for resurfacing Baymeadows Road. Please continue to report issues to his office.
- He voted to increase trash collection fees because the increase will essentially help the families of those who provide this essential service.
- The Avenues Mall has been underused. Simon Malls will utilize the underutilized portion of the parking lot to add multi-use family units. The Avenues Mall will remain open during the construction period.
- He has been in conversation with JTA about micro transit and will mention Planning District 3 for possible use in his subsequent conversation with JTA.

- Smoke detectors should be placed in areas where you sleep and should be tested at least once a month. They should be replaced every 4 years, or if they start to turn a yellowish color.
