Natalie Alden called the meeting to order at 12:35 P.M.

Introductions were made at 12:35 p.m. Clinton Hamilton provided an update for the month of September. Clinton Hamilton provided FY 2018 updates, DPEP- 3,105 citations were issued.

Natalie Alden and Dan O'Connor joined the meeting at 12:36 p.m. Clinton Hamilton provided an update on DPEP court hearings. The next DPEP parking court will be held on the 12th of October. DPEP had several outreach events in September including Mount Carmel and the Jacksonville Sheriff's Office safety fair. The next DPEP certification class will be held on November 1st and 2nd in 2018.
