II. Public Speaking

Randy Reaves, President of the Fraternal Order of Police (FOP) Lodge 5-30, addressed the Advisory Committee. He stated that the purpose of his remarks was to clarify the Police Union's position regarding disability retirements. Mr. Reaves explained the union's belief, supported by their binding contract and relevant case law, that when a member applies for and is granted medical retirement, the decision to accept a light duty assignment offered by the Jacksonville Sheriff's Office (JSO) rests with the individual member. While the union appreciates JSO's provision of light duty positions, which many members choose, they maintain that members who prefer to proceed with their approved medical retirement have the right to do so.

IV. Application for Disability Retirement – action requested a. MAZZONE, Mark

Discussion ensued regarding the application for disability retirement submitted by Mark Mazzone.

Thomas Lumpkin expressed concern about setting a precedent. James Holderfield clarified that the Advisory Committee needed a motion to either approve or deny the application to facilitate discussion.

Michael Shell moved to deny the application for disability pension, seconded by Michael Pelletier. Discussion:

Michael Shell referenced Randy Reaves' public comments, acknowledging the Jacksonville Sheriff's Office's (JSO) contractual tradition of providing light duty positions to maintain officers' service. He noted that Mr. Mazzone did not undergo the accommodation process, suggesting the situation would be different if JSO could not accommodate the employee.

Christopher Stover recalled a previous instance where a disability pension was denied due to the member not completing the accommodation process.

Thomas Lumpkin acknowledged the Medical Director's approval of the application but emphasized the Advisory Committee's responsibility to protect the fund. He raised concerns about the financial implications of approving the application without the member undergoing the accommodation process, referencing past cases where initially denied disability applications were later approved.

James Holderfield stated that he always relies on the Medical Director's recommendation regarding eligibility based on the plan design, which in this case was for approval, supported by two other doctors. He noted that the administration of JSO's accommodation process falls outside the Advisory Committee's purview.

Timothy Johnson stated that similar cases have been reviewed previously, including with the Board of Trustees. He clarified that the law does not mandate accommodation for a disability pension, contrasting the process for police officers with that of firefighters. He cited the Collective Bargaining Agreement (CBA) and the term "wishes" as indicative of the officer's preference. Mr. Johnson highlighted that the application was brought forward because it was deemed complete, noting three documented requests for accommodation from the member that JSO had the opportunity to act upon. He questioned penalizing the member for JSO's inaction on these requests and argued against delaying the application, as the law does not require accommodation for a disability pension.

James Holderfield noted that past delays in approving or denying disability applications have significantly increased costs to the plan. He urged the committee to mitigate high costs and liability by avoiding unnecessary delays.

Michael Shell reiterated his concern for the rigorousness of the process, particularly for younger applicants potentially unable to perform other jobs. He pointed out an inconsistency in the member's stated inability to write correspondence versus his ability to write to JSO.

James Holderfield clarified that the plan has mechanisms to review the disabled status of retirees for potential recovery.

Pedro Herrera acknowledged the difficulty in determining the permanence of disabilities but noted the opinions of medical professionals supporting the application. He concurred with the need to approve or deny the application.

Richard Reichard noted that the member passed his initial hiring physical without pre-existing conditions, indicating the disability developed during his career. He acknowledged the shared concerns but highlighted the Medical Director's opinion of 100% disability.

Thomas Lumpkin reiterated that two other doctors concurred with the Medical Director's assessment.

Timothy Johnson informed the committee of a new process involving a contracted licensed psychologist for additional review of disability applications at the Medical Director's request, which was not deemed necessary in this case. He also noted the streamlined process for handling new evidence, eliminating back-and-forth with the Board of Trustees. He explained that an approval would go to the Board for final decision, while a denial would trigger a hearing by the Board. He also suggested that stipulating accommodation as part of an approval might be futile if the member was unwilling to accept it.

Michael Shell stated that the file indicated the accommodation process did not occur, with no record of the member requesting or undergoing JSO's accommodation process.

Timothy Johnson clarified that the file contained evidence of three accommodation requests initiated by the member and acknowledged by JSO, though this didn't necessarily mean the member didn't engage with JSO's process. He reiterated that even if accommodation were pursued and refused by the member, the committee would be back in the same position. He stressed the need for a clear justification if the committee chose to deny the application, as it would proceed to a hearing before the Board of Trustees.

James Holderfield emphasized the Advisory Committee's lack of authority to impose stipulations on the member, noting that the application was complete according to their policy. He reminded the committee of the motion to deny.

Pedro Herrera stressed the importance of articulating the basis for any denial, specifically identifying any deficiencies in the application. He questioned whether a denial would be based on the lack of accommodation by JSO.

Michael Shell clarified that his motion to deny was based on the member's alleged inability to demonstrate an inability to provide useful and efficient service as a police officer to the Jacksonville Sheriff's Office.

The motion to deny the application failed, with Michael Shell and Michael Pelletier voting aye.

Richard Reichard moved to approve the application for disability retirement, seconded by Christopher Stover. The motion passed by a vote of 5-2, with Michael Shell and Michael Pelletier voting against.

V. Executive Director's Report

Timothy Johnson reported that the PFPF Staff were deeply saddened by the passing of former Trustee Bobby Deal. He announced the intention to dedicate the small conference room in his memory at a ceremony during the Trustee Breakfast in the fall.

Thomas Lumpkin supported this idea.

James Holderfield noted the historical significance of the room and the accomplishments of John Keane and Bobby Deal within it.
