IV. Executive Director's Report

a. July Hiatus – action requested

Timothy Johnson updated the Advisory Committee on two upcoming Summer Socials hosted by the PFPF, both to be held at the Firefighters' Union Hall. Members are welcome to attend either or both events. One social in July will be a BBQ, and the other in August will be a fish fry. Mr. Softee's Ice Cream truck, a popular hit last year, will be at both socials.

Timothy Johnson also reminded the Committee that the PFPF's Board and Committees traditionally take July off from public meetings. This allows Trustees and Committee Members to take vacations without scheduling conflicts. Historically, the Board and Committees vote in June to approve this hiatus.

Timothy Johnson noted that if the Advisory Committee approved a July hiatus, the August agenda would include two months of benefit approvals (for June and July). However, delaying these approvals would not affect members' pension payments, which would still be paid on time.

Thomas Lumpkin moved to approve the July Hiatus, seconded by Michael Shell. The vote passed unanimously.

Chuck Hayes congratulated Chief Michael Shell on his new appointment at Homeland Security. Hayes also informed the Advisory Committee about an upcoming Social Security seminar for members.
