Summary

I. Manager Update Workshop

a. Pinnacle Associates

Rich Rosen presented an overview of Pinnacle Associates' SMID growth strategy and the firm's long-term relationship with the Jacksonville Police & Fire Pension Fund, highlighting Pinnacle's 40-year history, employee ownership, stable and experienced investment team, and disciplined bottom-up, fundamental approach to investing. He explained the hybrid growth strategy, which blends sustainable growth and cyclical growth companies selected for strong growth potential, reasonable valuations, and identifiable catalysts, and described how the portfolio is constructed with strict risk controls, low turnover, and high active share. Rosen reviewed the Fund's strong long-term performance versus the Russell 2500 Growth Index, emphasizing significant outperformance since inception, robust recent results driven by broad-based stock selection, and a successful rebound from a prior period of relative underperformance. He also discussed portfolio positioning, including meaningful exposure to themes such as artificial intelligence, semiconductors, industrial automation, defense, energy security, infrastructure spending, biotechnology, and global sports franchises, and outlined recent buys, sells, and profit-taking activity. The presentation concluded by reinforcing Pinnacle's commitment to long-term, repeatable performance, disciplined portfolio management, and high-touch client service.
