President's Report

"Miles of Smiles." As of July 7, the SSA said it has processed more than 3.1million payments to those entitled to the retroactive payment adjustments, including many REA Members. The SSA has paid about \$17 billion to those beneficiaries. Earlier this year, the agency said the average amount of the retroactive payment was \$6,710. This chapter in our long fight to protect your Social Security benefits is nearly ready to close, with the remaining recipients awaiting individu-

al review due to their special circumstances.

2026 Social Security COLA projection. According to the latest estimates by the Senior Citizens League, the 2026 Social Security cost-of-living adjustment, or COLA, is now expected to provide a 2.7% increase for beneficiaries. This is an increase over the 2.6% projection the same organization made in June, which was already an increase over May. If the latest projection is correct, this would give the average retired worker a monthly raise of about \$54.

Seniors tend to spend a greater percentage of their income on healthcare costs than the overall population. They also tend to spend more (as a percentage) on housing. And according to the July inflation data, outpatient hospital services and housing costs have increased by 6.4% and 3.7%, respectively, faster than overall inflation. Medicare premiums will increase in 2026. Medicare Part B premiums are expected to be \$206.50. That's an 11.6% increase compared to this year.

Property insurance rates. Most rates have skyrocketed to unprecedented levels, with the average premium reaching over \$3,000 this year, a 34% increase from Q4 2022. If you're a homeowner, you're facing insurance costs significantly higher than most Americans, with the typical Florida policy now averaging \$5,376 annually for a home with \$300,000 in dwelling coverage—well above the national average of \$2,181.

Update on Ordinance 2025-361. Council Member Randy White introduced the **Retired Employees Adjustment** Ordinance, which will authorize a one-time payment to retirees in the amount of \$1,250.00. At this time, we have secured 9 co-sponsors for this Ordinance. The Ordinance is pending before Council Committees, awaiting final review and ruling by the Office of General Counsel.

Group Health Insurance Re-Enrollment. Your opportunity to make changes to your Group Health Insurance menu is just around the corner. Follow the directions from your Group Health office to ensure you are insured with the coverage you desire.

Pest-proof your house before fall rolls in

Autumn is just around the corner, and many common household pests will start scouting out the best places to hunker down for the winter. Your house is one of the most tempting targets around, but some basic pest prevention practices can encourage these unwanted visitors to hole up somewhere else.

According to the National Pest Management Association:

- Place screens over direct openings like attic vents, chimney openings, and mail slots.
- Inspect the outside of your home for cracks and crevices and seal them using caulk and steel wool.
- Pay special attention to the areas around utility pipes.
- Repair loose mortar around the foundation and windows.
- Eliminate spots where pests can hide and find ways inside. Trim shrubs, dispose of brush and garden waste, and store firewood at least 20 feet away from the house.
- Repair any damaged screens and make sure every door has a door sweep to seal the crack. Remember that rodents can get in through dime-sized holes.
- Replace weather stripping around windows.
- Keep attics, basements and crawl spaces dry. Use dehumidifiers if necessary.
- Make sure that your gutters are in good working order and effectively direct water away from your home.
- If you plan to bring anything inside after keeping it outside all summer (like potted plants or outdoor decorations), carefully inspect it first and



From the Secretary's Desk

Budget season is a good time to write the At-Large Council Members and your District Council Member, because this is the time Council gets serious about City finances and taxpayers like us can be most influential.

Two topics come readily to mind. First, File 2025-0361, the one-time supplemental payment to retirees. This legislation was introduced in Council by President Randy White on May 13th. It's been before the committees of reference and deferred, deferred, and deferred. As of 8/13 no action is pending, despite the fact that the proposed source of funding is our own pension plan! This is a good time to remind the sponsors (CP White, & CMs Johnson, Gay, Carlucci, Amaro, Gaffney, Jr., Carrico, Peluso & Pittman) that the time to take action is overdue. Retirees who would benefit from

passing this bill are dying while the committees repeatedly defer it to another day.

Second, there is a fight on to cut the millage rate and lower property taxes. While waiting in a doctor's office recently, I read an article in the San Marco community newspaper by CM Matt Carlucci who opposes this proposal. Cutting taxes is always popular with Duval voters; but, as Carlucci pointed out, the City is not flush with money. Lowering the tax rate as proposed will reduce this income stream by about \$25 million. Moreover, the benefit to an owner of a \$200 thousand home will be a reduction of only \$3.13 a month! I can hardly wait to spend that extra \$3.13 every month. Not! As Harry Reagan would say, "That's my opinion. We welcome yours." Contact your representatives and tell them what you think before they act.


Chaplain's Message - GIVE GOD ALL THE GLORY


