Isaac/Jason - Attached is a grid that shows how MEAG is proposing that various cost components are handled under each of the: (1) Sale of Ownership Interest and (2) PPA. In order to do your modeling, you will have to make certain assumptions as to how remaining MEAG debt (for construction, cap int, R&R) is structured, and how those DS costs run through the PPA. MEAG's previous work (and existing model) had only contemplated an overall combined Project J – not a JEA and MEAG portion. As such, they have not yet run a completion scenario that contemplates separate funding of two portions. They will be running those numbers over the weekend.
