#### **Tuesday May 1, 2018 Meeting, Disabled Services Conference Room C**

The Chair called the meeting to order at 12:36 P.M.

Clinton Hamilton provided an update for the Disabled Parking Enforcement Program for the month of April. Officer Hamilton provided revenue, citation issuance, court appearances, and quarterly training updates. DPEP Quarterly Training was held on April 13<sup>th</sup>. The next court hearing will be held on May 9<sup>th</sup>. Officer Hamilton presented awards to auxiliary members including Jimmy Smith for providing disability sensitivity training in quarterly trainings and FDLE certifications for new members. Officer Hamilton will be participating in JSO's Safety Fair on May 19<sup>th</sup>.

Natalie Alden recognized Clinton Hamilton's hard work in the Disabled Parking Enforcement Program. Ray Pringle also recognized the continued dedication to the program.

Jimmy Smith provided an update in Adaptive Recreation sports provided throughout the City. In April the City partnered with Brooks to host a Kayaking Clinic. The City also partnered with NuMotion and Brooks Rehabilitation to host a wheelchair repair clinic in April at the Cuba Hunter Center in which approximately 85 citizens participated. NuMotion has asked if the City would like to partner for more events in the future. Kevin McDaniel has asked that the next clinic be held in west/northwest Jacksonville.

Jose Morales stated for the record that the City does provide funding for wheelchair repair to the ILRC. Jimmy Smith stated that he spoke with the ILRC and the plan was to include them in future events. Ray Pringle asked that we ask if other agencies would like to participate in the event so there is no conflict of interest.
