Upstream of New Development

- Flooding
 - Elevated conveyance through new development
 - Added fill that creates conditions that block drainage
 - Avery Park









- **☐** <u>Upstream</u> of New Development
 - Flooding
 - Elevated conveyance through new development
 - Added fill that creates conditions that block drainage
 - Oriental Gardens (In-Fill Lot)









- **☐** <u>Upstream</u> of New Development
 - Flooding
 - Impacts to Groundwater?

• Filling low areas where groundwater use to "daylight" and, following development impacts, potentially creates an elevated groundwater gradient upstream.

- San Jose Estates (pictures)
- Avery Park










- Downstream of New Development
 - Flooding
 - Increased Flow from new development
 - Design did not account for all off-site contributing area and/or was inadequate to account for new development.
 - Maintenance of drainage during construction not addressed.
 - Flynn Road
 - Summer Walk



- **☐ Downstream** of New Development
 - Flooding
 - Flow Pattern Altered & Concentrated from new development
 - Design redirected flow and concentrated flow different than Pre-development which changes flow intensity to downstream property (one example is altering sheet flow to a point discharge).
 - White Oaks Farms (Aladdin Road)
